The Bid of the prospective Bidder will be considered only if the Pre-qualification criteria and the organizational capability of the bidder are found qualified by the Local Purchase Committee. The decision of the Local Purchase Committee will be final and absolute in this respect.

1. PREQUALIFICATION CRITERION:

i) Average Annual Financial Turnover during the last 3 years, ending 31/03/2018, should be at least Rs.3,00,000/-

ii) Experience of having successfully completed similar work, during 3 years within the last 7 years ending on 31/07/2018, should be either of the following:-

a) **Three** similar successfully completed works costing not less than the amount equal to Rs. 4,00,000/- each.

OR

b) **Two** similar successfully completed works costing not less than the amount equal to Rs. 5,00,000/-each.

OR

c) **One** similar successfully completed work costing not less than the amount equal to Rs. 8,00,000/- each.

2. GENERAL GUIDELINES FOR ITEMS TO BE SUPPLIED:

(i) The bidder must be a company registered under Companies Act, 1956/2013 or Partnership or LLP or OPC or Proprietary Firm. Documentary evidence (Certificate of incorporation/ Relevant document) to be submitted.

(ii) The bidder must have their main or branch office at Kolkata. Details of office location should be submitted alongwith the bid.

(iii) The bidder should have valid PAN, GSTIN No. & Trade License. Bidder shall have to submit photocopy of the documents.

(iv) The rate should be quoted inclusive of all taxes.

(iii) The items are to be supplied within 14 (fourteen) days of receipt of work order as per delivery schedule.

(iv) Utmost importance should be given on the quality of items to be supplied. It should be strictly as per specification and standard mentioned above.

(vi) Any item of substandard quality will be rejected out-right and the Director General of ATI, WB has the right either to cancel the supply order or invoke penalty as mentioned in this tender notice and/or ask the bidder to effect fresh supply of good quality of items within a specified date as mentioned by him.
