

Online Professional Phase II Training Course for WBCS (Executive) Probationers from August 24, 2020 to September 11, 2020

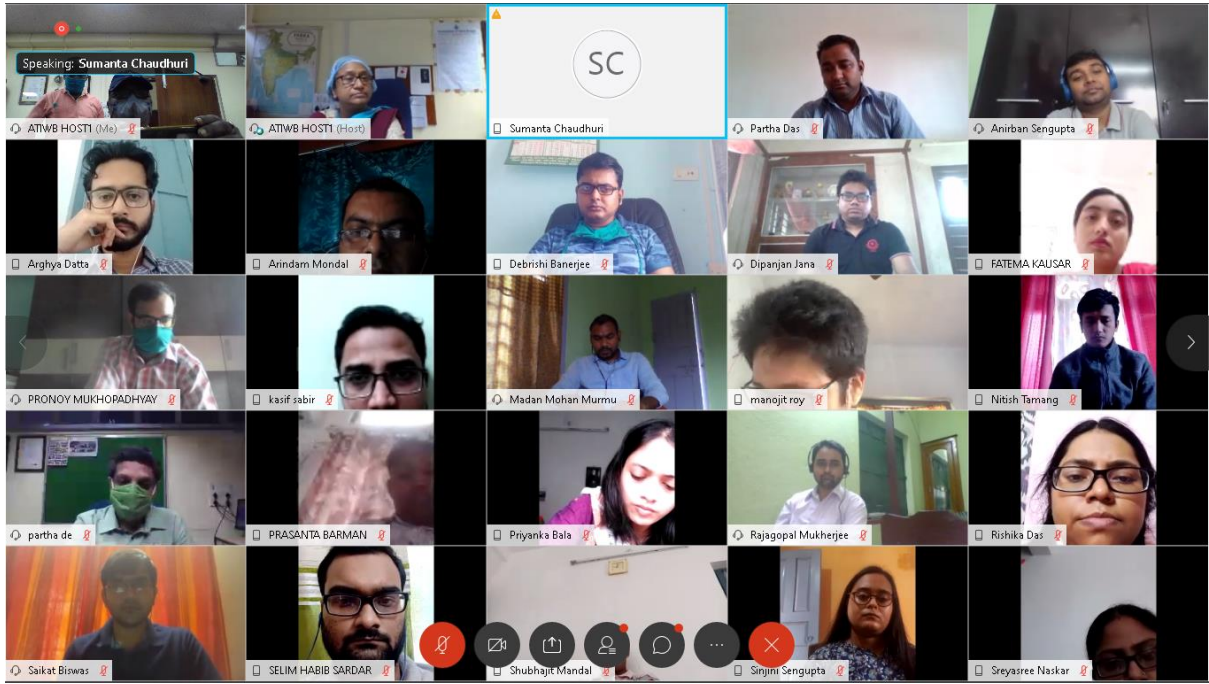

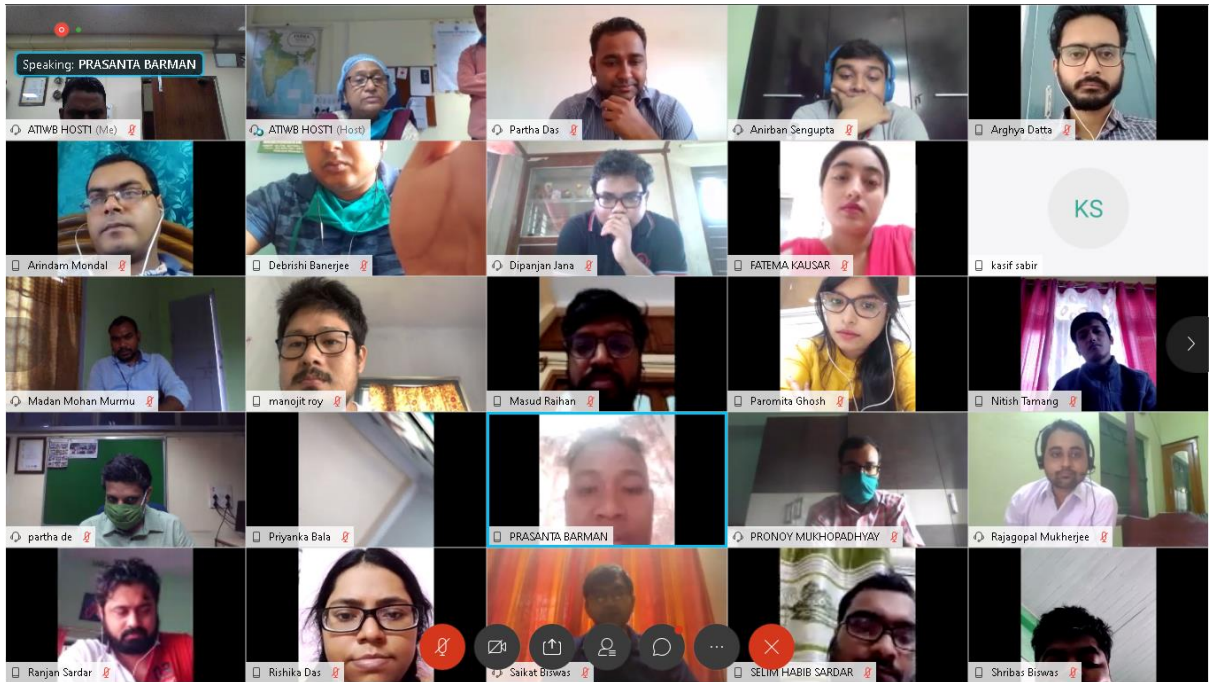
The course started with month long tutorial sessions for the Guest Faculty and Pre-course briefing with the participants to make them comfortable and conversant with the online system.

The IT and eGovernance Wing of ATI WB has been constantly supporting the course to make it a success.

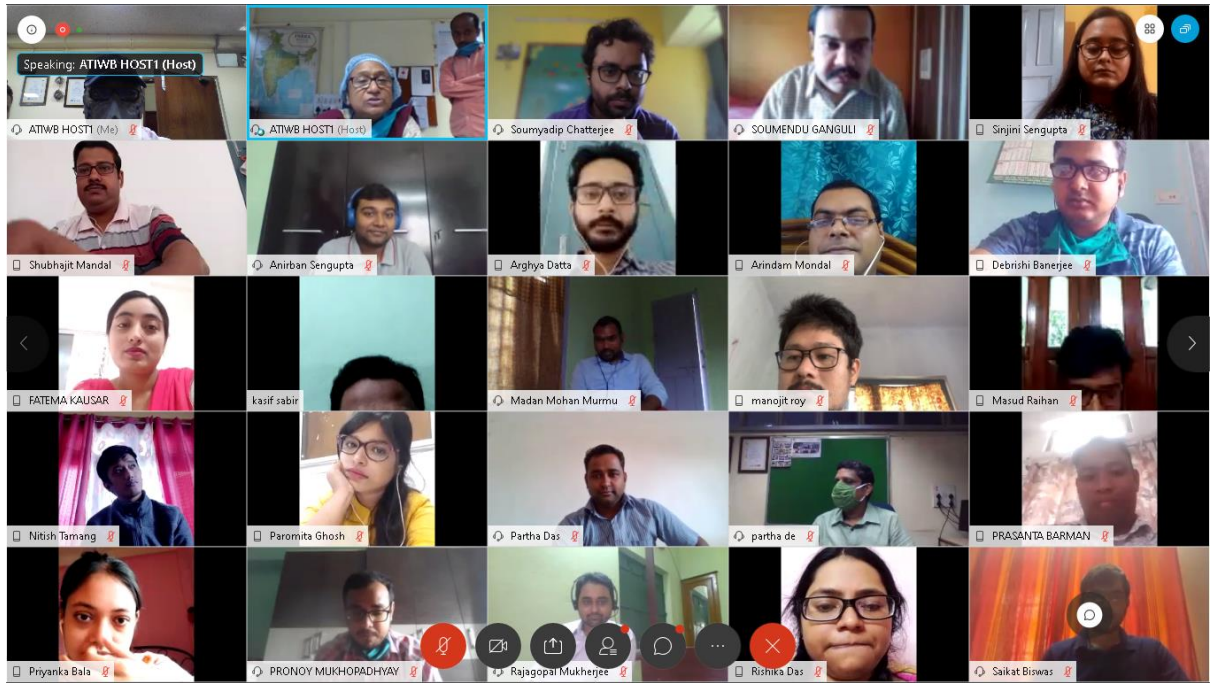
